

Sister Institution Agreement between

Shih Hsin University

and

Shadrinsk State Pedagogical University

Shih Hsin University, Taiwan, Republic of China and Shadrinsk State Pedagogical University, Russian Federation for the purpose of furthering cooperation-operation in both international education and cultural exchange, hereby affirm their intent to promote such academic exchange as will be of mutual benefit of their respective institutions. Academic exchange is considered to include but not be limited to:

1. To stimulate communication, cooperation, exchange, and partnerships between the two institutions, including students, faculty, research projects and curriculum, and thus to enhance the educational quality and resources of both institutions.
2. To cooperate in ways that can join or articulate their academic programs and services so that their students may take full advantage of international educational opportunity.
3. To explore and promote exchange opportunities for students, faculty and staff between the two institutions and to seek ways for these exchanges to participate in cultural activities within the host country.

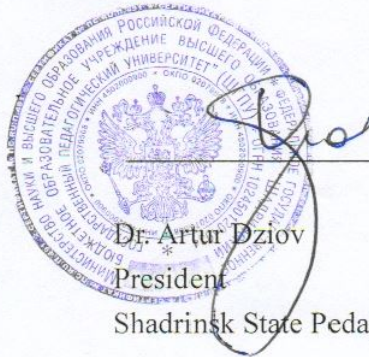
Details of the implementation of any particular exchange resulting from this agreement shall be negotiated between the two institutions as each specific case may arise.

This agreement to promote academic exchange is subject to revisions, renewal, or cancellation by mutual consent and becomes effective upon the signature of all relevant parties. This agreement is valid for a period of five years from the effective date and shall be automatically renewed for additional five years periods unless either party provides the other with written notice at least 90 days in advance that it wishes to terminate.

*Student Exchange Agreement between
Shadrinsk State Pedagogical University
and
Shih Hsin University*

SHIH HSIN UNIVERSITY, #1 Ln., 17, Sec. 1, Muzha Rd, Taipei, Republic of China (Taiwan), hereinafter referred to as SHU, hereby represented by its President Dr. Joe Y.C. Wu

and

SHADRINSK STATE PEDAGOGICAL UNIVERSITY, Shadrinsk city, Russian Federation, hereinafter referred to as SSPU, hereby represented by its President Dr. Artur Dziouv.

In order to advance and enrich academic programs of SHU and SSPU are herewith mutually entering into a formal agreement to promote exchange of students.

Title I - Reciprocal student exchange

Article 1

1. Qualifying students are those holding high academic standards who study at least one semester in SHU and those students from SSPU in the same way.
2. A maximum of three students will be sent to the partner institution each academic semester. It is agreed that three students enrolling for one academic year will be equivalent to three students enrolling for one semester.

Article 2

1. The exchange will be on a one academic semester basis, with equal numbers of incoming and outgoing students.
2. In the event of a difference in incoming and outgoing number of students, adjustments will be made on a yearly basis, with differences settled every two years.

Article 3

1. Students will be required to pass regular exams to obtain such credits and a grade transcript.

2. Exchange students will not be seeking a degree at the host institution and will attend regular classes.

Article 4

Both institutions shall offer relevant courses in Chinese/English for exchange students.

Article 5

Exchange students are exempt from paying tuition and dormitory fees at the host institution. All other expenses such as travel expenses, food, insurance etc will be paid by the students.

Article 6

Host institution laws, regulations and institutional procedures apply to all incoming students under this agreement.

Title II –Liaising

Article 7

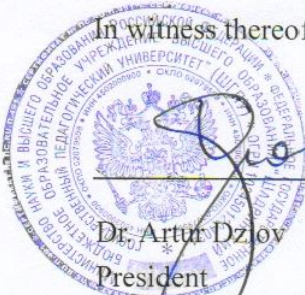
Each partner institution shall appoint a member of staff to be responsible for the implementation of the agreement and act as liaison between institutions.

Title III - Extent and Duration

Article 8

1. The agreement shall be in effect from the dates of signing by both parties, and may be subject to change, renewal, and termination by mutual consent.
2. Any alternation or amendment to this agreement must be made in writing and agreed and accepted by both parties.
3. The parties hereto may terminate the present agreement by delivering at least six months written notice of termination to the other party.

In witness thereof, the parties have signed two copies of this agreement, written in English.
